



Nova Gas Transmission (NGTL) West Path Delivery Project

In 2020, Meota Gas Co-operative Association Ltd. (Meota) was made aware of an upcoming Nova Gas Transmission/TransCanada Pipeline project making its way through our franchise area.

Project Information

NOVA Gas Transmission Limited (NGTL) has filed a Project application for the West Path Delivery 2023 (Project). The proposed Project includes the construction and operation of approximately 40.1 km of 48 inch nominal pipe size (NPS) in three sections, including:

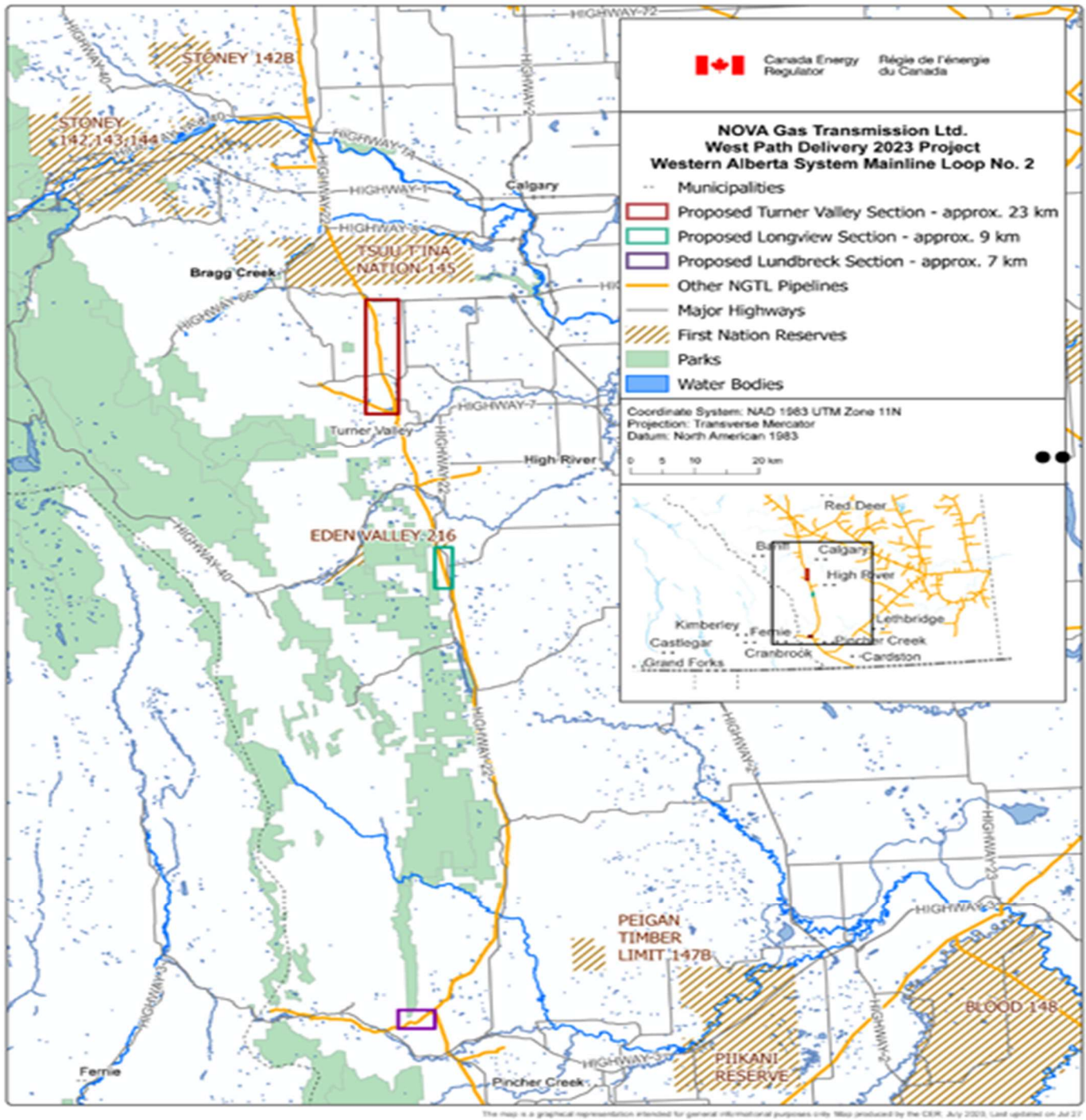
Pipeline section	Length	Location
Western Alberta System (WAS) Mainline Loop No. 2 Turner Valley Section (Turner Valley Section)	23.7 km	Approximately 3 km northwest from the Town of Turner Valley, AB
WAS Mainline Loop No. 2 Longview Section (Longview Section)	9 km	Approximately 30 km southwest of the Town of High River, AB
WAS Mainline Loop No. 2 Lundbrek Section (Lundbrek Section)	7.4 km	Approximately 30 km northwest of the Town of Pincher Creek, Alberta

The Project parallels existing infrastructure (such as the existing NGTL pipeline right of way, other pipeline right of ways, powerline easements and road allowances) for approximately 75% of the route. The Project will traverse approximately 5 km of Crown land and 34 km of private freehold land. The Project will require new permanent land rights. Temporary workspace is also anticipated to be required for the Project construction.

NGTL's current plans, if approved, are to start construction in the third quarter of 2023, with construction being completed in November 2023 and an anticipated in-service date of November 2023.

Meota's franchise area is affected on NGTL's Western Alberta System (WAS) Mainline Loop No. 2 Turner Valley Section.

Beginning in early February, Meota Gas and hired sub-contractors will be moving some of our gas distribution systems out of the way of NGTL's proximity and right-of-way to accommodate this line construction.

Our construction begins February 7, 2023 with an anticipated wrap up date of June 1, 2023.

During this time, we anticipate some short (1-2 hour) gas outages for a small number of directly affected customers. We will notify those affected with a minimum two (2) day advance notice.

Construction will begin just south of Priddis Greens Drive, moving south for approximately one kilometer. An additional five (5) re-routes are planned south of this initial stage.

Please note that this project will in no-way affect our member's fees or gas costs.
