LOCATE YOUR LINES - BEFORE YOU DISTURB ANY GROUND!

CLICK BEFORE YOU DIG - UTILITY SAFETY PARTNERS (FORMERLY ALBERTA ONE-CALL)

Natural Gas pipelines are buried underground, so it's easy to forget that natural gas is flowing all day, every day. Natural gas lines can be damaged because of failure to take a simple (but very important) safety measure before digging.

CLICK BEFORE YOU DIG and request a line locate to prevent damage, ensure public safety and avoid the inconvenience of outages.

If you are planning landscaping, construction, home addition, fence installation, porch/deck addition or any temporary structure, including modifications to existing structures, please notify Utility Safety Partners for a locate request.

Visit Click Before You Dig and within 96 hours, we will locate any natural gas lines on and around your property for free.

- Obtaining a line locate before excavation work is a legal requirement of Alberta Occupational Health & Safety and Pipeline Regulations.
- Damages to underground natural gas pipelines may result in personal injury, legal action, expensive repair costs and interruption of gas service.
- Line locates expire after 30 days provided all the original staking flags are in place and are only covered by the work area indicated on the locate.

ANNUAL GAS LEAK SURVEY

We maintain and operate many kilometres of pipeline to distribute natural gas to your homes and businesses. To ensure the integrity of our system, we perform an annual gas leak survey of the distribution system. The distribution system is divided into geographical areas with one-third of the system being checked annually. Therefore, within a three-year period, the entire system is checked entirely. For 2025, we will be walking lines and completing the annual leak survey from July to October.

SUMMER CONSTRUCTION

Summer construction projects are in the planning stages and 2025 will include some system upgrades in our area. We are in the process of planning and construction will begin in late July/August.

If your property is directly affected by any of Meota's construction activities, we will be in touch with you directly to keep you informed of activity plans and timelines.

If you are planning any construction activities to your home that may require alterations or changes to your natural gas service lines, please contact us **as soon as possible** to get your project estimated and in the construction queue.

NATURAL GAS DELIVERIES

Member-owned Utilities

Meota Gas owns the gas distribution system that delivers natural gas our customers in our franchise area. We operate and maintain the gas distribution system, install meters and secondary pipelines, and provide meter reading services. Our pricing is market-based, as compared to "customer choice" as offered by investor-owned utilities to their consumers. In addition to the cost of natural gas provided by Gas Alberta, Meota recovers our distribution and operating costs through


our monthly billing process. We set monthly rates with the approval of our locally elected board of directors on an annual basis.

Investor-owned Utilities

ATCO Gas North and ATCO Gas South are investor-owned utilities that own and operate the gas distribution systems in their franchise areas that deliver to their consumers the natural gas supplied by DERS (Direct Energy Regulated Services). AUI (Apex Utilities Inc.) carries out both the purchasing and delivery functions for consumers in their franchise areas.

The following chart summarizes the monthly rates charged by the investor-owned utilities to deliver natural gas to their consumers. These rates are designed to recover the utilities' natural gas delivery costs and other expenses, and are approved by the Alberta Utilities Commission (AUC).

DEFINITIONS

Cost of Gas — This is the cost of natural gas charged to Meota Gas Co-op from its wholesaler, GasAlberta. Meota Gas does not benefit from any increase or decrease in the rate charged per gigajoule (GJ) of natural gas. Meota Gas operates as a not-for-profit cooperative.

Delivery Charge – This charge is generated to cover the costs of delivering natural gas to Meota's customers/members and the costs for operating the cooperative. This fee is charged on the number of GJ's consumed.

Monthly Fixed Charge – This is the monthly flat rate charged to recover a portion of the total operating costs.

PAYMENT OPTIONS

Cheque – by mail or deliver to office. An after-hours mailbox is available.

On Line – Find Meota Gas Co-op as a payee. When referencing your account number, your financial institution may require more than your 4-digit account number. If so, please add zeros before or after your account number. (ie. 0004567 or 45670000)

E-Transfer – payments may be e-transferred to admin@meotagas.com. Please reference your account number in the notes. *Note: Meota Gas is set up for auto-deposit for e-transfers.

Auto Debit – Auto Debit payments are Meota's preferred method. Payments will be processed on the billing due date. If you wish to sign up for Auto Debit, kindly contact our office.

At your Bank – most financial institutions can process in-person payments.





Alberta One Call is now called Utility Safety Partners

Any ground disturbance on your property requires locates booked through Utility Safety Partners. Landscaping, new fencing or decks, or even planting a garden is ground disturbance and can cause damage to a buried utility. Some utilities are buried only centimeters below the surface.

The results of a contact with a buried utility can be loss of an essential service for you or your neighbours, costly repairs, and most importantly serious injury or death.
